II. Résumé and look ahead

Next year, we will celebrate the 20th anniversary of the Voluntary Guidelines on the Right to Adequate Food.

- These guidelines are viewed as a milestone in the implementation of the right to food on the international agenda – and rightly so!
- Let's not forget: It is a binding norm for states parties from the International Covenant on Economic, Social and Cultural Rights.
 - Our conference has thus been the resounding prelude to the upcoming anniversary and the starting point of a more intense integration of the right to food into our efforts to transform our food systems.
- The fact that we were able to bring together so many major players from that time shortly before the anniversary puts me in a very hopeful mood.

- In Germany, Renate Künast, who was Federal Minister of Agriculture at the time, substantially contributed to the development of these guidelines.
- I was absolutely delighted last night to hear her speech on this topic.
 - We will deepen our dialogue with the members of parliament on the right to food within the next months.
 - And we will also continue to talk with the private sector on how to better integrate the right to food in their business models.
- I am glad to hear that business representatives followed our invitation and took part in the discussions over the past two days.

Ladies and Gentleman,

- We at the BMEL view the recommendations from your working groups as a **starting point for further work** on implementing the right to food while transforming our food systems
- Especially now that the 20th year after the adoption of the guidelines is fast approaching.

- We will use these results to draw attention to just how important it is to also involve non-governmental stakeholders – and particularly, those from civil society – in the identification of solutions.
- And this applies to the national as well as the international level.
- The first opportunity to do so will be the upcoming Stocktaking Moment within the scope of the follow-up event on the United Nations' Food Systems Summit.
- We want to promote the work conducted by the CFS and use it to bring human rights-based approaches into the centre of Policies against Hunger.
- We want to consistently focus the BMEL's international collaboration on this goal by reinforcing our international and multilateral projects.

III. Closing

Ladies and Gentlemen,

We have to take the right to food as a fundamental human right seriously. Only then will we have a chance to beat hunger and all forms of malnutrition.

This conference was an important contribution to this aim.
